Meeting of February 7, 2012

The Planning and Zoning Commission of the City of Cedar Hill, Texas met on TUESDAY, February 7, 2012 at 6:00 p.m. in the T.W. "Turk" Cannady/Cedar Hill Room, 285 Uptown Boulevard Building 100, Cedar Hill, Texas.

I. Call the meeting to order

Chairman Brooks called the meeting to order at 6:05 p.m. declaring it an open meeting in which a quorum was present and the meeting notice was duly posted.

IV. Case No. 11-36 – Review and Consider the Site Plan of a 15,250-sq. ft. non-residential building Lot 4R-A, High Meadows Addition, generally located on the east side of High Meadows Dr., south of Edens Way. Requested by Charles Crook.

Andrew Kubiak of Charles Crook Consulting Engineers, Inc., 1506 West Pioneer Parkway, Suite 207, Arlington, TX 76013 stepped forth to present this request and answer any questions from the Commission.

Chairman Brooks asked the applicant if he was aware of staff's comments.

Mr. Kubiak stated yes, he was aware of those comments and has actually made revisions to the plans, but has yet to re-submit the plans.

Commissioner Hamilton asked the applicant if the Building Appeals & Advisory Board granted an exception to the 40 ft. setback, as required by the 2006 International Building Code

Mr. Moore stated yes.
