
**MINUTES
PLANNING AND ZONING COMMISSION
MEETING OF MARCH 21, 2023**

The Planning and Zoning Commission of the City of Cedar Hill, Texas met on Tuesday, March 21, 2023 at 6:00 p.m. in the T. W. "Turk" Cannady/Cedar Hill Room, 285 Uptown Blvd, Bldg. 100, Cedar Hill, TX.

1. Call the Meeting to Order.

Vice-Chairperson Patton called the meeting to order at 6:01 p.m. declaring it an open meeting in which a quorum was present, and the meeting notice was duly posted.

2. Approve the minutes of the February 21, 2023 regular meeting and the March 7, 2023 workshop.

A motion was made by Commissioner White and seconded by Commissioner Hendon to approve the minutes of the February 7, 2023 regular meeting and March 7, 2023 workshop. The vote was as follows:

4. Public Hearing Items:

- 1. West Midtown Master Plan** - Conduct a public hearing and consider a recommendation to adopt the West Midtown Master Plan.

Director Stringfellow briefed the Commission on the request. Due to technical difficulty, the presentation could not be viewed.

Vice-Chairperson Patton asked if there were any questions for staff from the Commissioners.

Commissioner McCain stated that keeping the discussion on the connectivity between Midtown and Downtown in the forefront was important.

Commissioner Auzenne commented the parking situation should also be kept in the forefront.

Vice-Chairperson Patton opened the public hearing. He asked if there was anyone wishing to speak in support of this request. No one came forward.

Vice-Chairperson Patton asked if there was anyone wishing to speak in opposition of this request. Wes Pool at 615 E. Belt Line Road, Cedar Hill, TX, indicated his concerns for the plan were in limiting the height and allowing cluster homes. However, he did not have opposition to the other proposed concepts.

Vice-Chairperson Patton closed the public hearing.

Vice-Chairperson Patton asked the Commission if there were additional questions of staff.

The Commissioners indicated that the plan is to facilitate how development is to occur in the area. However, zoning and constructions plans are still to be determined.

1. **Case No. FP-533-2023** – Consider an application for a final plat for the Brook View Addition, Lot 1, Block 3 and a variance to Section 20-22(b), Chapter 20 – Subdivision Regulations on property zoned "SF-E" (Single-Family Residential Estate with minimum 1-acre lots) District located on the north side of High Drive, east of Tar Road with the approximate address being 320 Simmons Way.
