**I. Call meeting to order.**

Mr. Joe Pitt called the meeting to order at 6:32 pm with a quorum present.

**II. Approve the minutes from August 15, 2022.**

**III. Citizen Forum**

**IV. Review and consider the property located at Meadow Vista Estates 1<sup>st</sup> Section; Block F; Lot 61; more commonly known as 1432 Meadow Vista a public nuisance and direct staff to abate the nuisance.**

The owner was denied a variance request to the Zoning Board of Adjustments. The owner has obtained a permit to perform the demolition but has not completed it as of today.

Mr. Jack Frost made a motion to declare the property located at 1432 Meadow Vista a public nuisance and give the owner 30 days to bring the property into compliance or staff is to take further action to abate the nuisance. Mr. David McDaniel seconded the motion. The motion was approved unanimously.

**V. Review and consider the property located at Brook View Unrecorded; Block 5; Lot 7; Acres 1.04; more commonly known as 507 Evergreen Trail a public nuisance and direct staff to abate the nuisance.**

Mr. Gail Lux provided a summary of the actions that Code Enforcement and Building Inspections have taken bring this property into compliance. The owner has applied for a permit to demolish the main structure but has failed to pay for the permit and start demolition.

Mr. Jack Frost made a motion to declare the property located at 507 Evergreen Trail a public nuisance and the structure substandard and give the owner 30 days to bring the property into compliance or staff is to take further action to abate the nuisance. Mr. David McDaniel seconded the motion. The motion was approved unanimously.
