Statement of Intent:

The above described Right-of-Way is to be vacated in its entirety, save and except for the conditions specified in **Conditions Addendum** labeled "**Exhibit C**" attached hereto and made a part hereof.

All City of Cedar Hill Franchise Utility Companies have agreed to this proposed Vacation/Abandonment subject to the conditions listed on Exhibit B as evidenced by the Franchise Utility Company's representative's initials and signatures on **Franchise Utility Co. Vacation/Abandonment Approval** attached hereto and labeled "Exhibit D".

A List of all the property owners owning property abutting the above referenced street ROW being vacated are provided on the attached “**Exhibit E**”. Each of these property owners agree with the proposed street ROW Vacation/Abandonment as evidenced by their signatures on the attached **Right-of-Way Vacation and Abandonment Consent Form**, attached hereto, and labeled “**Exhibit E**”.

The Undersigned proposes due compensation to the City for its relinquishment of Right-of-Way as is required by State Law. The compensation proposed with this Vacation/Abandonment is described in **“Exhibit F”** attached hereto and made a part hereof.

As evidenced by their signature on Exhibit E, these property owners support this Right-of-Way Vacation and abandonment. These property owners have been made aware that the vacation and abandonment of this ROW will result in the issuing of a Quit Claim Deed, which will convey land from the centerline of the ROW being vacated and abandoned to the adjacent property owner. The **Quit Claim Deed** is signed, properly attested, attached hereto, and labeled "**Exhibit G**".





QUIT CLAIM DEED

STATE OF TEXAS
COUNTY OF DALLAS

KNOW ALL MEN BY THESE PRESENTS:

That the City Council of the City of Cedar Hill, County of Dallas, State of Texas, after careful study and consideration, has determined that a certain Street Right-of-Way known as _____, hereafter specifically described, is not being used by, nor useful or convenient to the public in general; therefore, it constitutes a public charge without a corresponding public benefit, and the public would be better served and benefited by its Vacation/Abandonment and abandonment. For and in consideration of the above findings and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the City of Cedar Hill does hereby bargain, sell, release, vacate, abandon and forever quitclaim unto GRANTEE and any and all heirs, legal representatives or assigns, all of its right, title and interest in and to the following described real property situated in Dallas County, Texas, to wit:

TO HAVE AND TO HOLD all of its right, title and interest in and to the above described Street Right-of-Way unto the said Grantee, heirs and assigns forever, so that neither Grantor nor its heirs, legal representatives or assigns shall have, claim or demand any right or title to the aforesaid utility easement, premises or appurtenances or any part thereof.
